TAKE NOTICE THAT in accordance with the Case Management Rules for the District Court of the 18th Judicial District (Rules 20 & 21), the parties to all custody actions shall complete Custody Mediation Orientation and participate in Custody Mediation prior to a trial on the issues unless the Court waives either or both events.

The FILING PARTY in this case shall:

Within five (5) days serve the OPPOSING PARTY with a copy of this Notice by personal delivery or by mailing it. A copy shall be filed with the Clerk of Superior Court.

Attention OPPOSING PARTY:

Failure to comply, once you have been served, will not delay the entry of an Order, which may award the relief sought.

IT IS ORDERED THAT BOTH PARTIES in this case shall:

1. Unless previously completed, REGISTER for a CHILDREN OF DIVORCE class within ten (10) days. The parties are to contact the Family Life Council of Greensboro at (336) 333-6890 or Family Services of the Piedmont (High Point) at (336) 889-6161. Each party shall pay his or her respective fees charged by the provider. A Certificate of Completion shall be filed in the court file.
2. Unless previously completed, ATTEND a MEDIATION GROUP ORIENTATION at the Guilford County Courthouse in the appropriate venue:
 - In Courtroom 2A, Greensboro, NC
 - In Courtroom 3A, High Point, NCon Wednesday, _____ from 12:30 to 2:00 p.m.

If you think that mediation is inappropriate for your case, call 336-574-4339.

3. ATTEND AT LEAST ONE MEDIATION SESSION. The mediator will be assigned and the first session scheduled at Orientation. If you have previously attended a mediation session, call 336-574-4339.
3. Unless previously completed, ATTEND a COURT INFORMATION SESSION the first Tuesday of the month your case is scheduled for hearing in Courtroom 2E of the Guilford County Courthouse, Greensboro, North Carolina at 9:30 a.m.
